Secret Settlements Now Made Public

Show no Increase in Number of Malpractice Suits Filed or Payments Made to Victims

Physicians throughout the state have been urging the state legislature to impose severe restrictions on your right to sue a doctor and to recover fully for injuries caused by him or her. They and the New Jersey Medical Society have long claimed that "frivolous lawsuits" and "jackpot" jury awards have driven up the cost of their insurance policies and made it difficult for them to afford coverage. In opposing such limitations, lawyers at Blume Goldfaden along with committed lawyers from around the state have argued that any problems doctors are having in obtaining liability coverage are due to other causes, such as bad business decisions made by the insurance companies, and not because of a supposed explosion in claims or in the amounts paid to victims.

Now, the court-ordered release of previously confidential data pertaining to cases that have been resolved, has proved that the number of medical malpractice cases has actually decreased over the last several years, as have the amounts of payments made to people injured by physician negligence. In considering what to do about

The Victims' Compensation Fund was created by Congress in October 2001 to save the airlines and the Port Authority from being sued by thousands of victims. The Fund provides compensation to families and victims who, in exchange for a recovery from the Fund, give up their right to file a lawsuit. Over 1,000 attorneys from all over the United States including 231 from New Jersey formed "Trial Lawyers Care" and offered their professional ser-

High School Teacher Run Over by Truck

\$1.5 Million Settlement



A 53 year old former high school teacher recently accepted a settlement of \$1.5 Million after being run over by a pick-up truck as she was crossing a street in Newark. "My client sustained numerous fractures to her pelvis, sacrum, shoulder, back and ribs and underwent surgery to her thigh",

according to partner, Ron Goldfaden, "but the worst part of the accident, by far, is the fact that she can no longer do what she loved most: teach."

Wrongful Death

\$2.75 Million Recovery for Family of Jayson Williams Shooting Victim



After two days of mediation, Ken Berkowitz negotiated a \$2.75 million dollar recovery for the family of Gus Christofi, a 55 year old limousine driver who was fatally shot on February 14, 2002 by ex-New Jersey Nets star Jayson Williams. Christofi had driven Williams and others home follow-

ing a Harlem Globe Trotters charity basketball game. While giving guests a tour of his home, Williams removed a shotgun from a firearm rack, pointed the gun at Christofi and snapped the gun shut, discharging the weapon into Christofi's chest. At the time of the settlement, the criminal charges against Mr. Williams were still pending.

the doctors' claims, the legislature had asked for this information from the various insurance companies providing malpractice coverage in the state, but they had refused to produce it. Insurance companies routinely insist upon confidentiality when making settlements, preventing attorneys from providing the information. Recently, a state court ordered that information pertaining to medical malpractice settlements and payments made in the past few years be made public.

The data revealed that the response by our state legislature was justified. It passed a law which slightly modifies the rules for filing medical malpractice cases but for the most part does not further limit your right to sue bad doctors or doctors who make mistakes which cause serious injury.

As always, we are committed to fighting for the rights of those who are injured by the negligence of others — including doctors — and we are proud that our voice and yours was heard in Trenton.

Inadequate Security

\$1.8 Million Settlement - Sexual assault at ATM



Carol Forte obtained a settlement on behalf of two women who were attacked at a bank ATM. The lawsuit alleged that the bank failed to provide adequate security, because the parking lot was poorly lit and there were bushes in which the criminals hid before attacking the victims.

Improper Surgical Clearance

\$4 Million Settlement for Brain Injury

Carol Forte obtained a \$4 million recovery on behalf of a 24-year-old man who was inappropriately given the go-ahead to have general anesthesia for surgery on his jaw. The patient, then 19, had abnormal preoperative EKG and chest x-ray results but this escaped the attention of all his doctors, and he was permitted to undergo the planned surgery. During the operation the patient suffered a cardiac arrest due to those underlying abnormalities, resulting in lack of oxygen to his brain causing memory loss.

\$3.2 Million Verdict - Birth Injury



A Middlesex County jury awarded a \$3.2 million verdict in a case involving a birth injury to a seven-year-old girl. There is permanent damage to the girl's brachial plexus nerves (known as an Erb's Palsy) which required surgery to her left arm. Michael Zerres tried the case on behalf of the infant child. The matter

subsequently settled for a confidential amount.

\$4 Million Verdict - Birth Injury

A Gloucester County jury returned a \$4 million verdict in a case involving a birth injury to a six year old girl. The injury caused permanent damage to the girl's brachial plexus which will require future surgery on the arm. Michael Zerres tried the case on behalf of the little girl. The matter subsequently settled for a confidential amount.

Work Site Wrongful Death

\$975,000.00 Recovery for Family of Worker Killed in Accident



John Blume settled a wrongful death case on behalf of a 45 year old Somerset County worker who was fatally injured while repairing a traffic signal. The victim was standing in an elevated basket high above the ground, when a car struck the vehicle he was standing in. He fell, sustained multiple fractures and internal

injuries, which caused his death later that day.

Wrongful Birth

\$1.225 Million Settlement for Child with Fragile X Syndrome



Fragile X Syndrome, a condition which can be diagnosed prenatally, is the most common cause of inherited mental retardation. It occurs in approximately one in 1,200 males and one in 2,500 females. In this case, Dennis Donnelly recovered a settlement of \$1.225 million for a 4 year old boy who was born with

Fragile X Syndrome because the mother's doctors failed to perform proper testing to screen for this condition.

Additional Failures in Prenatal Diagnosis

\$3.84 Million Verdict and \$1.25 Million Settlement; Two Additional Cases of Failures in Diagnosing Profound Birth Defects.

Dennis Donnelly obtained a jury verdict of \$3.84 million for a missed diagnosis of a profound chromosome defect by obstetricians, which resulted in profound retardation and institutionalization. He also obtained a settlement at trial of \$1.25 million for a missed diagnosis of Canavans disease, a fatal and debilitating neurological disease.

vices at no charge to the victims who needed legal help applying for benefits from the Fund. As a TLC volunteer, Cynthia was assigned two claims; one for the death of a 34-year-old bond trader who left a young widow and the other for the death of a trader who died at age 40 leaving a wife and four children. Over the next two years Cynthia spent hundreds of hours assembling the necessary documentation, organizing the evidence to substantiate the claims and presenting the claims to the Fund. As a result of her efforts, this year one widow received a gross award of \$3.8 million and the other received a gross award of over \$5.5 million.

Jeff has been acting as New Jersey counsel for the widow and three children of a 37-year-old trader who was also in the doomed World Trade Center that day. He represented her at a hearing for the distribution of nearly \$3.5 million, assisted the family in collecting the proceeds of an insurance policy, and coordinated benefits for them through state agencies. We are all proud of Cynthia and Jeff for volunteering their services to help in this worthwhile cause.
