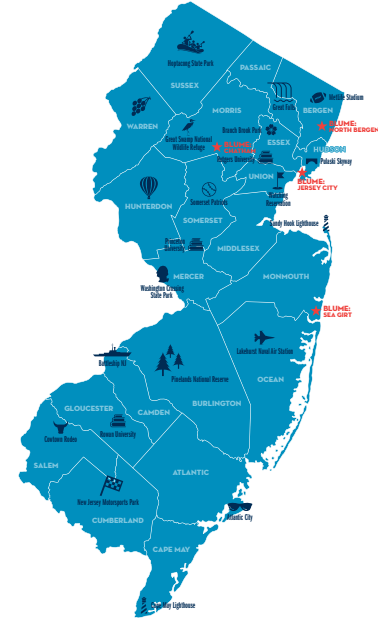

# Recoveries

## **\$6 Million - Carol L. Forte** **Radiology malpractice**

A 45-year-old single mother of 3 had a screening mammogram. The images were reviewed later that day by a radiologist who recognized findings concerning for breast cancer. The radiology technician at the imaging center was supposed to send the patient a letter telling her of the findings and that she needed to return for more testing, but instead, sent a form letter telling her the mammogram was normal. Sixteen months later, cancer was diagnosed that was then at stage 3 of 4 breast cancer stages. After years of treatment, including potent chemotherapy, surgery and radiation, she died of breast cancer that had spread throughout her body. After three weeks of trial, the case settled for \$6 million.

## **\$1.75 Million - Carol L. Forte** **Medical malpractice**

A 72-year-old woman fell out of bed in the hospital after having brain surgery. After having the surgery, the patient was disoriented.

Discovery showed that the nurse caring for the patient probably incorrectly set the bed alarm, which would have sounded and alerted the staff to the fact that the patient was trying to get out of bed if it had been correctly turned on. The patient fell, striking her head and requiring emergency surgery for head trauma.

## **\$3.75 Million - Carol L. Forte** **Kidney surgery malpractice**

A man with severe diabetes and kidney failure was recommended by his kidney doctors and vascular surgeons to have a procedure known as renal artery stenting, for the claimed purpose of improving blood flow to the kidney to obviate the need for dialysis. However, hours after the procedure, blood clots formed, cutting circulation to the feet and eventually resulting in amputations and later, death. The defense claimed that the patient did not want to go on dialysis and wanted to try this instead, that the amputations were due to the diabetes and not the procedure, and that his death was statistically not premature. Discovery showed that the procedure had been discredited in the medical literature for this type of patient

years earlier. Before his death, the patient also claimed that he had not agreed to have a new surgeon, inexperienced in the procedure, perform it.

## **\$2.5 Million - John E. Molinari** **Motor vehicle accident**

A 57-year-old plaintiff was struck by a car while he was riding his motorized bicycle. Plaintiff was previously retired from his municipal government position as a result of being inflicted with myasthenia gravis, which causes weakness in the skeletal muscles. At the hospital following the crash, the plaintiff underwent cervical and thoracic fusions. Nearly one year later, he was again hospitalized due to aggressive weakness in his extremities and underwent a second multilevel fusion. Plaintiff underwent several rounds of physical therapy following the procedures.

# Specialization, experience, and resources all add up to success

If you don't practice personal injury law regularly and a client walks into your office with an injury, reach out to us to analyze the matter, as there are often avenues of recovery that only an experienced personal injury lawyer will be able to detect. Besides the fact that it is in the best interests of your client to have additional areas of recovery and giving a client an incomplete analysis could be considered malpractice, you may also get a significant referral fee upon conclusion of the matter. Some of our pending and recent cases highlight the importance of having all injury matters reviewed by a lawyer who specializes in personal injury law:

1) A client was injured at a jobsite and has a workers' compensation claim against his employer. His employer created a dangerous condition at the jobsite. Reach out to determine if another entity could be held at fault for the accident. Our case law establishes enhanced duties on a general contractor. Even when it

seems that only the employer is liable, claims may be made against the general contractor for not inspecting the worksite for dangerous



conditions. Our firm has been successful on many such claims.

2) A client is injured in a motor vehicle accident by a single owner-operated truck. The injuries are severe, and the truck has only \$1 million in insurance coverage. Reach out to us to analyze if, in fact, a vicarious claim can be made against the company for whom the truck driver was hauling. We have been successful in recovering significant additional funds for such claims.

3) A client is injured in a factory by a co-employee's negligence: A) a co-employee turned on a machine while the client's hand was still in the machine, or B) a co-employee lowers a door that strikes the client. Reach out to determine if a product liability claim can be made against the machine manufacturer for not having an appropriate guard on the machine. Additionally, there may be a proper guard on the machine, but the



machine may not be affixed with appropriate interlock technology. As to the door example, the door may have landed on the client because a sensor was not properly installed to detect an object in its path and thus disable closing. We have handled many such cases and are currently involved in many.

4) A client may tell you he or she was involved in a motor vehicle accident caused by a drunk driver. The police report may say nothing about where the defendant became intoxicated, and you may have no information about where or when the defendant drank

alcohol last. Extensive investigation may reveal that the defendant became intoxicated at a bar, or someone's house, and there may then be a viable dram shop claim to pursue. We have had many such cases and have many now.

5) A client may be involved in a garden variety motor vehicle vs. pedestrian accident that occurred at night. There may only be limited insurance coverage for the motor vehicle accident. In-depth investigation may reveal, however, that the area where the incident occurred was dark because streetlights were negligently maintained, and the dark street



contributed to the client being struck by a motor vehicle. We have had and currently have such cases.

Additional examples of less apparent claims we have pursued include claims against car manufacturers, trampoline component manufacturers, bed manufacturers, etc for faulty product design, as well as claims for subsequent medical malpractice that occur while the client is receiving treatment for a traumatic injury sustained in a more straightforward trip and fall or automobile case. In short, reach out to us to review the particular facts of your client's injury case. There are often additional avenues of recovery to pursue, and we have the experience and resources to pursue them.

# Do you know the symptoms of a stroke?

Every year, approximately 800,000 people in the United States have a stroke.

A stroke is a disruption of blood flow to the brain. Without oxygen, brain tissue begins to die. Undetected or late detected strokes can lead to serious, life-altering, permanent

injury or even death. Early recognition is the key to proper stroke treatment and thinking **FASTER** might help you save a life.

Use these clues to detect some common symptoms of strokes to relay to medical professionals:

**F** Face. If there is an uneven smile or one side of the face droops or is numb.

**A** Arms. One arm drifts down when raising or is weaker/more numb than the other.

**S** Steadiness. Hard time keeping balance. Trouble walking or loss of coordination.

**T** Talking. Slurred words or unable to speak or understand speech.

**E** Eyes. Difficulty seeing out of one eye or both; double vision.

**R** React. Call 911 immediately even if symptoms go away. Remember when the symptoms began.



Over the last 20 years, there have been significant advancements in the way doctors can treat strokes. Depending on the type of stroke that is diagnosed, it can be resolved by surgery and or the administration of a medication called tissue plasminogen activator (tPA).

A tPA and surgery, if needed, must be given within a specific time period; therefore, it is critical that the timing of the onset of symptoms be accurately conveyed to the health care providers at the hospital. Per the American Stroke Association, the window of effectiveness for tPA is approximately 4.5 hours from stroke onset.

Hospital personnel are trained to recognize the symptoms of a stroke, and they will take a medical history, conduct a physical examination, and order the necessary tests such as blood work and imaging known as CAT scans. Treatment will then be tailored to the type of stroke, with the goal of restoring blood flow to the brain.

If the stroke is untimely diagnosed or undiagnosed, or there is a delay in initiating treatment, the patient has lost critical time and potentially has lost the ability to get lifesaving treatment. ## The law clerk program at Blume Forte

Another important element in the success of Blume Forte is the work of the law clerks whom we hire each year. In fact, more than half of the attorneys with the firm began their professional careers at Blume Forte as law clerks, dating back to the 1980s. In a program at Blume Forte dating back decades, law students entering their final year of classes have been hired from Seton Hall Law

School, Rutgers Law School, and New York Law School to assist our attorneys in doing investigations, performing legal research, and drafting legal documents (including proposed discovery requests and responses, court submissions, and pleadings).

The candidates who apply – for the next term there were nearly 100 applicants – are

evaluated based upon their scholastic grades and achievements, research and writing abilities, and nonacademic endeavors. When chosen to participate in the process, the best candidates are then interviewed. Those chosen to become our law clerks then work for a full year within the team of the assigned attorney(s), providing significant contributions to the work done for our clients.

Over the years, the overwhelming majority of our law clerks have gone on after graduation to serve as law clerks for judges in both trial courts and appellate courts, including for justices of the Supreme Court of New Jersey. The skills they learn at Blume Forte will serve them for their careers in litigation and other areas of the law, and the work they do on behalf of our clients is invaluable.

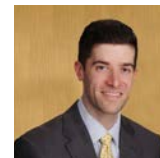
